## **Executive Summary**

The Corporation of the Municipality of West Nipissing (Municipality) retained the services of D.M. Wills Associates (Wills) to undertake a review of the Municipality's existing road network, and assess its physical condition as well as confirm various road attributes. Data collected during the field review was used to develop a prioritized listing of the road network needs, the results of which are documented in this report.

The Municipality's road infrastructure system spans a total of 547 km primarily within a rural setting, with small areas of urban and semi-urban development. The road network includes surfaces ranging from gravel to hot mix paved (asphalt). The Municipality has approximately 429 km of gravel roads, 45 km of surface treated roads (low class bituminous (LCB)), and 73 km of hot mix asphalt paved roads (high class bituminous (HCB)).

Two primary indicators of the relative health of a road are the structural adequacy and surface condition ratings. The current average structural adequacy rating for the Municipality's road network is 13.8/20. The current average surface condition rating for the Municipality's road network is 7.0/10.

# 2% (12.1 km) of the road network has a Structural "NOW" need, 4% (24.5 km) has a Structural "1-5" year need, and 6% (34.0 km) of the road network has a Structural "6-10" year need.

It should be noted that a structural "NOW" need does not explicitly mean that work must be undertaken on the road immediately (although this may be so in some cases). A structural "NOW" need means that a significant portion of the road is showing distress of the road bed and requires significant intervention i.e. reconstruction or major rehabilitation to renew it service life. A structural "1–5" year need is expected to become a "NOW" need in the next five years, and a "6–10" year need is expected to become a "NOW" need in the next 10 years.

Note that many "6-10" year reconstruction needs may be deferred by timely resurfacing, extending their service lives. As highlighted above, the Municipality has a notable portion of their roads (6%) with a" 6–10" Year Structural Need.

#### **Resurfacing and Preservation Management**

In addition to addressing currently deficient roads (i.e. capital reconstruction), a dedicated preservation management approach is required, <u>and perhaps even more</u> <u>important</u>, to "keep the good roads good"; the fundamental principle being that it costs much less to maintain a good road than it does to let it fail and then reconstruct it, from a life cycle cost perspective. Ultimately, the goal of preservation management is to extend the useful life of a road and road network, maximizing the Municipality's investment over the road life-cycle.

Road resurfacing is an effective way of extending the overall life of the pavement structure and therefore a road resurfacing program is highly recommended. Roads with a structural adequacy of 12/20 or greater are included as candidates for potential resurfacing. Preliminary recommendations and prioritization for road resurfacing are based on condition rating and traffic demands on each road section, as per the Inventory Manual. A road with higher traffic volumes and fair structural adequacy is given priority over a road with moderate traffic and good structural adequacy score, in an attempt to intervene and extend the life of the road before it deteriorates to a level that can no longer be resurfaced (i.e. more expensive reconstruction is required). Specific resurfacing treatment recommendations must be assessed through further field investigation and detail design effort, prior to selecting and implementing the resurfacing strategy.

Based on typical degradation rates for gravel roads, surface treatment, and hot mix, a resurfacing program and related budget is recommended as follows:

#### Hot Mix Paved Roads:

- 73.4 km of paved roads (HCB).
- Degradation rate 0.25 / year (rating drops from 10 to 5, over a 20-year period).
- Annual resurfacing 3.7 km / year.
- Annual budget \$1,546,600: (3.7 km / year x \$209,000 / ln RMP1 x 2 lanes).

#### Surface Treated Roads:

- 45.0 km of surface treated roads (LCB).
- Degradation rate 0.625 / year (rating drops from 10 to 5, over a 7-year period).
- Annual resurfacing 6.4 km / year.
- Annual budget \$268,800 (6.4km / year x \$42,000 / km \$T1).

Gravel roads require regular maintenance. Maintenance includes regular grading and reapplication of new gravel. Typically, gravel roads should be resurfaced on a 3 - 5 year cycle.

#### Gravel Roads:

- 428.5 km of earth / gravel roads.
- 100 mm gravel every 5 years.
- Annual gravelling of 85.7 km.
- Granular A (\$31,000 / km).
- Annual budget \$2,656,700 (85.7 km / year x \$31,000 G) \*\*.

\*\* Cost based on supply of Gravel only with application of gravel by internal forces.



# Based on typical degradation rates for gravel roads, surface treatment, and hot mix, a total resurfacing program, (hot mix, surface treatment and gravel) is estimated at \$4,472,100 per year.

Further to the recommendations above with respect to resurfacing, it is also recommended that regular maintenance in the form of roadside ditch cleanout and brush clearing be undertaken as a critical component to preservation management in order to extend the useful service life of the existing roads.

#### **Capital Improvements**

Preliminary recommendations and prioritization for planned capital improvements i.e. reconstruction, have been developed based on the condition rating and traffic demands on each road section, as per the Inventory Manual. Those roads identified as having a "NOW", 1 - 5, or 6 - 10 year need have been included in the capital improvement plan for reconstruction.

A total length of 70.6 km of roads were identified as having structural needs in the "NOW", 1-5 or 6-10 year periods. The estimated cost to improve these roads is approximately \$18.2 M.

It is important to highlight the network's average structural adequacy score of 13.8/20, as noted previously. A significant portion of the Municipality's roads are approaching a condition that will require reconstruction, as opposed to less costly resurfacing.

# A fully funded 10 year plan following the recommendations in this report includes \$4.5 M/year for resurfacing needs and \$1.8 M/year for the capital needs over ten years.

Given that a majority of the Municipality's Road network have a structural need of 6-10 years or no structural need, Wills recommends that priority should be given to resurfacing and preservation over capital needs should funding fall short of ideal levels.

#### 5.1 General Government Committee

1. <u>Cache Bay Trailer Park Sale Update</u>

The Chief Administrative Officer provided Council with an update on the recent closing of the tender for the sale of the Cache Bay Trailer Park. An Agreement of Purchase and Sale has been entered into and is scheduled to be completed on December 15, 2023.

2. By-Laws and Policies available on the Municipality of West Nipissing Website (A. Tessier)

Council discussed a request from Councillor Tessier to have all of the municipality's by-laws published on the municipality's website. The CAO indicated that translation of existing bylaws and policies is an ongoing process and that many of the municipality's by-laws remain in a form which may not be compliant with AODA legislation and will require update to a format which would make them accessible.

#### 3. <u>Process for evaluation of Chief Administrative Officer</u>

The Director of Corporate Services provided information regarding the process for evaluation of the Chief Administrative Officer. There is a policy currently in place which may require update in order to bring it into conformity with current standards and practices for employee evaluations. The process may assist in formulating a job description which will assist in future recruitment processes. It was suggested that an ad hoc committee be struck in order to work on the formulation of the proposed policy. The Mayor, Deputy Mayor, Councillor Gagné and Councillor Tessier volunteered to sit on the committee which will commence work on the new policy in the near future.

#### 4. <u>Conseil des Arts de Nipissing Ouest (CANO) - Request for Financial Assistance</u>

The Director of Community Services provided some background information regarding the past financial arrangements with CANO. The Director stressed that it is important that the municipality consider what sort oversight the municipality has to have on an organization, depending on the financial contribution level. In the past, there were some concerns regarding the financial information provided by the proponents followed by a request for the termination of the contribution agreement. It was suggested that a financial forecast be sought in order to better analyze the request and it was also suggested that there be a member of council on the CANO board.

#### 5. Delegations to ROMA conference (deadline Nov. 20-2023)

Council discussed potential delegations at the upcoming ROMA conference. Members suggested that the Champlain Bridge be re-visited with the Ministry of Transportation and that the new Minister of Housing be brought up to date on the housing and homelessness in West Nipissing and rural Northern Ontario. it was also suggested that the Ministry of Municipal Affairs and Housing be sought in order to discuss the composition of the DNSSAB and the under-representation of West Nipissing. It was also suggested that the matter of the Au Chateau be revisited with the new Minister of Municipal Affairs and Housing.

#### 6. <u>Proposed Annual Budget Meeting Dates</u>

The CAO requested input from council on potential budget dates. Mr. Barbeau indicated that his preference would be to start with a Saturday session on November 18 which would provide a good starting point. The Mayor has reached out to members who have indicated concurrence with Saturday November 18. Availability was also sought for the following two (2) weeks for evening meetings. Staff will follow up with an email to all members of council.

#### 5.2 Social Services and Health Committee

#### 1. <u>Community Safety and Well Being Plan Update</u>

The CAO provided a brief update to council on the Community Safety and Well Being Plan which was adopted by Council in 2022.

#### 2. Homelessness in West Nipissing

Recently, West Nipissing is seeing an increase in homelessness which has come to the forefront through by-law enforcement. The CAO arranged a recent meeting with DNSSAB, the Health Unit, Alliance Centre, the Community Health. Mr. Barbeau noted that all of the agencies present at the meeting are individually dealing with parts of the issue, however there appears to be a lack of coordination and systemic attention to the problem. Mr. Barbeau indicated that it is incumbent on all of the parties to coordinate to find a longer-term solution

than that which the local groups are capable of providing. There are facilities in North Bay, however the affected individuals do not want to go to North Bay. Council will have to consider how best to address the situation whether it be at the local level or in cooperation with partners in other communities.





### **Policy Statement and Rationale:**

It is the objective of the Municipality of West Nipissing, Public Works Department to apply its operational activities in a consistent and sustainable way, to ensure public safety by meeting or exceeding the current Minimum Maintenance Standards provided for in the Municipal Act SO 2001 c. 25 and the Minimum Maintenance Standards O. Reg. 239/02.

### Scope:

This policy shall apply to all roads and sidewalks assumed and maintained as public roads by the Municipality of West Nipissing. Not withstanding the foregoing, neither the Corporation of the Municipality of West Nipissing nor its officials or employees make any promise, assurance or guarantee that the services provided by the Public Works Department will be in excess of the minimum standard, as required by regulation and detailed herein. Inherent within the standard is the expectation that drivers and pedestrians will act responsibly and will operate their vehicles, at all times, reasonably with due regard for the prevailing weather and roadway conditions.

### **Policy:**

**"AADT"** Average Annual Daily Traffic is a technical measurement of traffic volume on a road, in both directions. Conversion factors, which vary depending on time of year and week, extrapolate daily traffic counts into AADT. (See seasonal.)

"Ambient Conditions" are conditions that are commonly found in a stabilized environment. Normally in ambient conditions there are no negative effects actively reducing the existing conditions. i.e. Storm, excess traffic or construction effects are not in evidence. (See storm conditions.)

"Aspects" in the context of these standards refer to specific elements of roadway service, which are defined by these standards.

"As Soon As Practicable" capable of being done and feasible given the circumstances.



**"Class"** in the context of these standards refers to the criteria for classifying roadways as set out in O. Reg. 239/02 Minimum Maintenance Standards

"Conditions" define the state in which the subject matter is found. The standard indicates the condition being measured.

**"Cycle"** is that time interval between Winter Maintenance conducted for a specific purpose on any identified road segment. Consideration can still be made for inspection cycle time adjustments at the discretion of the city's Supervisor or designate for mitigating circumstances, which are of an uncommon, or unpredictable, nature.

"Day" is a calendar day.

"Desirable" describes that level of service standard the roadway authority has established as an objective for road department operations.

"Effect" is the acting of an external influence on the condition of any aspect of the roadway

"Hardtop" refers to a road surface, which is relatively hard in nature, by treatment with either a bonding agent or cement, which effectively prevents reshaping by conventional motor grader.

"Improved" condition refers to the condition being better than it was before, from the perspective of a typical user, all other effects being equal.

"Inspection" is the activity performed by a qualified person, authorized and directed by the Director of Public Works or designates, to investigate and report on the relevant conditions of the roadway. General inspection has regard for road surface and roadside standards. Winter inspection has regard for winter road surface standards.

**"Lane"** is that portion of the road designated for a single file of vehicles to travel over, in one direction. For roads where two-way traffic is permitted, the lane width is half the road width unless otherwise delineated by pavement marking.

"Localized" conditions, for the purpose of these standards, that occur on short lengths of roadway specifically on bridges, intersections, curves and hills.

**"Loosetop"** refers to a road surface that is of a granular manufactured product, which can reasonably be shaped by a motor grader, and includes road surfaces under reconstruction.

**"Maintenance Priority Classes"** means the priority for roadway maintenance services as defined by Table 1 of the level of service policy; roadway maintenance classification.

"Notice" of an effect or condition is considered given when received by an appropriate employee of the road authority.

**"Operations"** means those activities the Public Works Department performs to improve a condition or sustain a roadway standard. Operations are normally defined by guidelines (not policy), with discretion of the supervisor to choose various methods to achieve results cost-effectively.



"**Policies**" decisions of a formal nature made by the road authority to enable, qualify and govern the mission of the road authority as directed by-law.

"Priority" an order of the Class of roads to be maintained during a winter event.

**"Response"** describes that action taken by the roadway authority when informed of an effect or condition. Monitoring an effect or condition may constitute a response. A reasonable response takes into account the relevant standards.

"**Right Of Way**" (R.O.W.) describes the corridor of land reserved for roadway improvements and under the jurisdiction of the roadway authority. Certain rights of way infer a right of passage to the public. However, in the context of these standards, only rights of way with assumed public roadways are considered. Rights of way solely for non-vehicular traffic are not addressed in these standards (e.g. Pedestrian, equestrian, bicycle.)

**"Road"** refers specifically to the traveled road surface on a roadway assumed by a roadway authority, but not including on-street parking or stopping zones.

**"Roadside"** refers to all features that make up the roadway within the jurisdiction of the roadway authority, except for the road surface itself.

**"Roadway"** in the context of these standards means any public assumed road right of way, intended for vehicular traffic. It refers not only to the traveled road surface, but to all services relevant to the road, within the right of way. In the context of an urban road this includes the traveled portion plus the ancillary lanes. In the case of rural roads this includes the ancillary lanes and the shoulders.

**"Roadway Authority"** indicates the public agency accountable for the status and condition of the roadway. This refers to the Municipality of West Nipissing and its designated officials or agents.

**"Section"** refers to a portion of roadway with a distinct classification, and homogeneous character. A roadway section is commonly used for construction costing, inventory control in Maintenance Management Systems, Road Needs Studies, Pavement Management Studies, and Priority Planning and Budgeting.

"Seasonal" refers to the limited time of the year where certain roadway service standards apply to the subject roadway. (eg. Summer roads, Winter roads). In the context of these standards seasonal roads are classified as those not receiving winter services, unless otherwise defined.

"Service" can be defined in two contexts. In the larger context any government activity is a service. A roadway network is a service, as is a library, potable water supply, etc. When used in the context of these standards, "service" refers more specifically to aspects of a roadway and their condition. Services are seen from the perspective of the user.

"Service Level Matrix" the Table(s) established within this policy that specifically defines the service level according to Class of roadway.



"Service Levels" a range of values that quantify a particular service standard, by one or more parameters, across a range of roadway classifications. Service levels typically reflect a maximum or minimum condition.

**"Shoulder"** that maintained surface immediately adjacent to the traveled surface of the road. The shoulder may be partially or fully hardtop, loosetop, grassed, or earth. It is not considered a part of the road for these standards.

**"Sidewalk"** a hard surfaced, typically concrete or asphalt pathway within the public road allowance intended for the use of pedestrians.

**"Snow Accumulation"** means the natural accumulation of any of the following, alone or together:

1. New fallen snow.

2. Wind-blown snow

<u>3. Slush</u>

**"Snow Packed"** conditions refer to winter road conditions where the traveled surface of the road is covered with a build up of snow and/or ice.

**"Speed"** refers to the average speed at which an average automobile can safely travel on a road without the effects of traffic. This does not refer to design speed or legal speed unless specifically qualified. Posted speed is either legal or advisory.

"Standards" quantified statements, defining the nature of a product or activity. Usually such standards are minimum or desirable, and in this context refer specifically to the roadway service standards adopted as policy, by a roadway authority.

**"Storm"** conditions or effects are when natural or external effects are acting upon the roadway to reduce the condition as defined by one or more roadway service standards. It does not refer to weather conditions that do not impact on the infrastructure. Storm conditions could include wind, rising and/or moving water, precipitation, cold temperatures (below -15C), snowfall, freezing rain, hail, blowing snow, etc.

**"Substandard"** refers to a condition that is outside the defined standard. Normally a substandard condition requires a response, unless otherwise considered in the standard.

**"Supervisor"** refers to a person in the Public Works Department who is accountable for the deployment of operations that impact on the condition or roadway services.

**"Surface"** the exposed top of the traveled road and includes adjacent surfaces for turning or stopping, but not parking or shoulders.

**"System"** refers to a collection of roadways, typically of various classifications, owned by a single road authority.

**"User"** refers to any person traveling on or over the roadway, including vehicle operators, passengers and pedestrians.



"Winter" the season when cold weather effects on road conditions can be reasonably expected and as specified herein.

#### Winter Response and weather monitoring

This level of service policy covers these activities which are required to produce safe driving conditions for a driver acting responsibly, during those times of the year in which winter conditions can be anticipated.

Weather monitoring will be done by the area foreman as per O. Reg 239/02: Minimum maintenance Standards for Municipal Roads.

The winter maintenance resources of the Municipality of West Nipissing consists of single axle, tandem axle combination plow/spreader trucks and graders equipped to plow, as well as loaders with hydraulic snow blades and blowers for snow removal (if required) and trackless sidewalk plows, with sufficient operators for the current number of plow routes, organized in a one day shift. In order to ensure that these resources are employed as efficiently and effectively as possible, the Municipality of West Nipissing adopts a policy of having the resources deployed generally when the needs are required as per the adopted Levels of Service.

A full call out of winter maintenance resources between the hours of 9:00 pm and 4:00 am will not as a general rule be made except where weather and road conditions deteriorate to the state where the travelled road network has compromised the road users' safety.

Winter maintenance activities covered by this policy include continuous plowing, spot plowing, continuous sanding (sand with 5% salt), spot sanding (sand with 5% salt), ice blading, winging back banks, snow removal and sidewalk plowing, and road patrolling during normal ambient and storm conditions.

#### **Snow Clearing Level of Service**

The policy for snow clearing is to deploy resources as soon as practicable to clear snow accumulations after becoming aware of the fact that the snow accumulation is greater than the depth set out in Table 1 below and to ensure that the accumulation of snow is maintained at a level less than or equal to the maximum depth indicated within the time allowed for in the policy for the duration of the storm.

Once the snow accumulation has ended, and within the time specified after the end of the storm, the objective shall be to return the road to at least the minimum surface condition as shown in Table 1 in accordance with O.Reg 239/02 Minimum Maintenance Standards for Municipal Highways. Class 1, 2, 3 and 4 roadways, clearing operations will clear the snow from the edge of roadway and all ancillary lanes and ramps etc. Class 5 roads with two lanes, if after the snow accumulation has ended, the snow accumulation is greater than the depth set out in Table 1, the objective will be to clear the snow accumulation to a depth less than or equal to the depth set out in Table 1 and to a width of at least the width of the 3.0 metre lane and shall be maintained and open for the public's use within the time period, after the end of the storm. Once the snow pack has been adequately established on the roads, the objective will be to remove all new fallen snow and reinstate the hard pack surface with winter abrasives within the time frames indicated. Ice blading of snow packed surfaces will be undertaken as necessary to



provide a traction as determined by the Area Foreman or designate (Supervisor, Acting Supervisor or Lead Hand under the direction of the Area Foreman).

The maximum allowable accumulation provision of this policy does not apply to that portion of the road designated for parking. Snow removal from parking areas will only be completed after all other areas have been cleared.

#### Sanding Salting and/or Ice Blading

The objective will be to deploy resources as soon as practicable, after becoming aware of the fact that the road surface is in a snow or ice covered condition and the safe operation has dropped below the threshold indicated in Table 2. The response will be to treat the road way or sections thereof as appropriate to remove the ice or provide traction within the timeframes indicated in Table 2 for such response.

It is the objective of the actions taken to improve the surface conditions of the road within the time shown in Table 1, such that the safe operation on the road will meet or exceed levels as shown in the Table 2.

#### Winging Back Of Snow Banks

At various times during a winter season it may be necessary to wing back snow banks in order to reduce the height of the banks so that driver visibility is not impaired and/or provide space to store additional snow. Typically this work will be undertaken in rural and urban residential areas.

The objective will be to deploy resources within a reasonable time frames after becoming aware that the snow banks are impacting vehicle sight lines.

No objective is established for the necessity to wing back banks for purposes of creating additional snow storage. Such work will be undertaken as and when it is deemed necessary to do so by the Supervisor and



time is available to undertake such work between winter events and other priority work. While winging back may occur at private driveways during these operations this is coincidental, individual property owners are responsible for site line and snow storage concerns for private driveways.

#### Snow Removal

Removal and disposal of snow in an approved snow disposal facility is carried out in those areas where inadequate physical space exists to store the snow and/or the presence of snow banks interferes with the movement of pedestrian traffic. Snow will be removed from the central business districts of the Municipality of West Nipissing and other designated built up areas within the Municipality.

No objective is established for the necessity to remove snow. Such work will be undertaken as and when it is deemed necessary to do so by the Supervisor and when time is available to undertake such work between winter events and other priority work. While snow removal may occur at private driveways during these operations this is coincidental, individual property owners are responsible for site line and snow storage concerns for private driveways. Property owners should store snow from private driveways on their property to avoid site line issues on the road.

#### Winter Maintenance of Sidewalks

The policy for snow clearing is to deploy resources as soon as practicable to clear snow accumulations after becoming aware that the snow accumulation is greater than the depth set out in Table 3 below and to ensure that the accumulation of snow is maintained at a level less than or equal to the maximum depth indicated within the time allowed for in the policy for the duration of the storm. For the purposes of this policy addressing snow accumulation on a sidewalk includes,

- (a) plowing the sidewalk;
- (b) sanding the sidewalk (sand with 5% salt mixture);
- (c) applying abrasive materials to the sidewalk;
- (d) any combination of the methods described in clauses (a) to (c).

The Municipality will provide a single pass of a sidewalk unit providing a minimum one-meter-wide pathway for pedestrian travel.

#### Icy Sidewalks - Sanding and Salting

The objective will be to deploy resources as soon as practicable, after becoming aware that ice has formed o a sidewalk, or part thereof. The response will be to treat the sidewalk or sections thereof with abrasives (sand with 5% salt mixture) to treat the ice or snow and provide improved traction within the timeframes indicated in Table 3 for such response.

#### Winter Sidewalk Inspection Level of Service – Routine Conditions

Inspection is that activity which the road authority undertakes to inform itself of, and document the condition of, its sidewalks. The Municipality of West Nipissing shall inspect its sidewalks via a representative route and shall be performed to achieve the requirements outlined in O.Reg 239/02 Minimum Maintenance Standards for Municipal Highways. Patrolling a sidewalk consists of visually



observing the sidewalk, either by driving by the sidewalk on the adjacent roadway or by driving or walking on the sidewalk, and may be performed by persons responsible for patrolling roadways or sidewalks or by persons responsible for or performing roadway or sidewalk maintenance activities. Sidewalks which are regularly patrolled include but are not limited to the following roads: Main, King, Larocque and Principal.

#### Winter Patrolling Level of Service –Winter Season Conditions

Winter patrolling during the occurrence of winter events, conditions shall be in accordance with Table 4. Patrolling shall be carried out by driving or monitoring of weather service providers to ascertain conditions and the need for a response. Patrolling of a representative sample of the road system shall be deemed to be sufficient to identify problem areas. At a minimum patrolling will occur as per O. Reg 239/02 Minimum Maintenance Standards for Municipal Highways

#### Winter Patrolling – Night, Evening and Weekend Conditions

During the season when a municipality performs winter highway maintenance, the minimum standard for patrolling highways is, in addition to that set out to that noted above, to patrol highways that the municipality selects as representative of its highways, as necessary, to check for conditions requiring winter control maintenance.

- Water treatment plant (parking lot)
- Beach parking lot (Main St)
- Scout parking lot (John St)
- Fire Hall (John Street)
- Sturgeon Falls Arena and Complex Parking Lots
- Minihaha Driveway and Parking
- Fire Hall (Crystal Falls) (Dubuc Road)
- Fort Road Parking lot
- Cache Bay Post Office -parking lot
- Cache Bay Fire Hall -front and back parking
- Club 50 -west of building (Cache Bay)
- Cache Bay Rink
- Public Works garage (Cache Bay)
- Dock Road Parking
- Parking off Teal Rd
- Verner Arena Parking Lot
- Fire Hall (Verner)

The objective will be to deploy resources as soon as practicable, after becoming aware that snow or ice has formed in a parking area, or part thereof. The response will be to treat the parking lot or sections thereof with or abrasives (sand with 5% salt) to treat the ice or plow snow and provide improved traction as soon as practicable. Municipal Property maintained by contractors is not listed above.



#### Private Roads

# **Level of Service Policy**

The Municipality provides winter maintenance for the following private roads:

- Point Road (550m)
- Prang's Lane (1.08km)
- Pellerin Road (1.06km)
- Argo Road (130m)
- St-Jean Road (505m)
- Alfred (360m)
- Cayouette (1.0km)

The objective will be to deploy resources as soon as practicable, after becoming aware that snow or ice has formed on the road. The response will be to treat the road or sections thereof with or abrasives (sand with 5% salt) to treat the ice or plow snow and provide improved traction as soon as practicable.

#### **Cemeteries and Landfills**

The Municipality removes snow from the following cemeteries and landfills:

- Field cemetery on Highway 64
- Verner cemetery on Highway 575
- Cache Bay cemetery on Thibeault Road (as requested)
- River Valley Landfill
- Verner Landfill
- Kipling Landfill
- Field Landfill
- Muskosung Landfill

The objective will be to deploy resources on a as needed bases, after becoming aware that snow or ice has formed on the road and clearing is required for access. The response will be to treat the road or sections thereof with or abrasives (sand with 5% salt) to treat the ice or plow snow and provide improved traction as soon as practicable.

#### **Occasional Winter Maintenance**

The following roads are typically unmaintained in winter, however on occasion the Municipality will remove snow from the following roads:

• Pike Lake Road (Past regular snow plow turnaround)

The objective will be to deploy resources once or twice a winter, after becoming aware that significant snow or ice has formed on the road. The response will be to treat the road or sections thereof with or abrasives (sand with 5% salt) to treat the ice or plow snow and provide improved traction as soon as practicable.

Natures Trail Road is not maintained during the winter.



#### **Declaration of a Significant Weather Event**

As per Regulation 239/02 of the Municipal Act 2001, an Ontario municipality may declare a significant weather event when a weather hazard is approaching or occurring and has the potential to pose a significant danger to users of the highways in which they have authority over. This declaration suspends the standard timelines required for municipalities to meet their winter maintenance objectives until the municipality declares the significant weather event has ended. In each case, during the course of a declared significant weather event, the standard for addressing winter maintenance is to monitor the weather and to deploy resources to address the issue starting from the time that the municipality deems it appropriate to do so. When the municipality has declared the event has ended, the standard timelines for winter maintenance activities will begin.

The Municipality of West Nipissing may declare a significant weather event when the weather forecast or actual weather condition includes one or more of the following conditions:

- Significant snow accumulation during a 24-hour period,
- Ice formation that occurs with no warning from the weather forecast,
- High winds leading to large snow drifts,
- Cold temperature when abrasive application (sand with 5% salt) will not be effective.

The CAO or designate has the authority to declare a significant weather event. In the event the Municipality of West Nipissing declares a significant weather event the Municipality will notify the public in one or more of the following ways:

- 1) By posting a notice on the municipality's website.
- 2) By making an announcement on a social media platform, such as Facebook.
- 3) By notification through the municipality's police service provider, and emergency services.
- 4) By any other notification method required in a by-law of the municipality. O. Reg. 239/02.



Between The North Bay Parry Sound District Health Unit

> And The Municipality of West Nipissing

#### INTRODUCTION

The Municipality of West Nipissing and the North Bay Parry Sound District Health Unit commit to partnering in the implementation of the Icelandic Prevention Model with the aim to mitigate risk factors, enhance protective factors, and decrease the likelihood of substance use among youth.

#### PURPOSE

The purpose of this Memorandum of Understanding (MOU) is to outline is to outline the collaborative partnership and demonstrate the commitment of the North Bay Parry Sound District Health Unit and the Municipality of West Nipissing to positively influence the lives of children and youth, specifically through the implementation of the Icelandic Prevention Model.

#### BACKGROUND

Youth substance use rates in Northern Ontario are higher than the province as a whole.<sup>1</sup> Early adolescent substance use dramatically increases the risk of developing a substance use disorder.<sup>2</sup> Understanding the multiple risk and protective factors that contribute to youth substance use, and addressing these early on, are critical to prevention at the population level.<sup>2,3</sup> Early substance use shares risk factors with other outcomes including school attendance, graduation rates, violence, delinquency, mental health issues, and homelessness. Interventions aimed at influencing risk and protective factors have potential to produce positive ripple effects in multiple areas of student health, well-being, and life success.<sup>4</sup>

The <u>Icelandic Prevention Model (IPM)</u> is an evidence-based, comprehensive approach that has demonstrated effectiveness in reducing youth substance use by strengthening protective factors and mitigating risk factors within the family, school, peer-group, and leisure-time contexts. The approach is driven by a biennial survey of grade 10 secondary students that reveals the local status of substance use and correlations with risk and protective factors. The survey results are disseminated and used by community partners to inform interventions designed to create a social environment where young people become progressively less likely to engage in substance use.

#### RESPONSIBILITIES

Implementation of the Icelandic Prevention Model requires the cooperation and collaboration of many partners, groups, and individuals. Roles and responsibilities for the Health Unit and the Municipality of West Nipissing are outlined below.

#### All signatories on this MOU will:

- 1. Offer in-kind contributions, where possible, to support the Icelandic Prevention Model community development.
- 2. Participate in discussions and decision making with respect to funding the IPM.
- 3. Abide by the Icelandic Prevention Model Terms of Reference as approved by the West Nipissing Icelandic Prevention Model Steering Committee.
- 4. Work collaboratively to maintain the Icelandic Prevention Model governance structure.

#### The North Bay Parry Sound District Health Unit will:

- 1. Provide a staff coordinator for the project for the duration of the 5-year term.
- 2. Provide funding of up to \$5,000 per year for 5 years to support Icelandic Prevention Model costs.
- 3. Coordinate and fulfill all Planet Youth required documentation, payments, and reporting.
- 4. Coordinate and fulfil all Public Health Agency of Canada required documentation and reporting.

- 8. Conduct school selection, school contact, and preparation for Planet Youth core questionnaire survey administration.
- 9. Support the administering of the school surveys in line with Planet Youth standards.
- 10. Provide a community level report after each round of data collection (every 2 years) to give guidance to intervention decisions at various community planning tables.
- 11. Support the design and implementation of community-based intervention strategies based on findings from the surveys and recommendations by Planet Youth.

#### The Municipality of West Nipissing will:

- 1. Participate in the development and working elements of the local Icelandic Prevention Model Steering Committee with attendance at meetings and work collaboratively with participating partners.
- 2. Provide funding of up to \$5,000 per year for 5 years to support Icelandic Prevention Model costs.
- 3. Review quarterly and annual budget reports provided by the Health Unit.

#### TERMS OF UNDERSTANDING

#### **APPENDIX 1: Definitions**

The **Icelandic Prevention Model (IPM)** is an evidence-based primary prevention approach focused on engaging whole-communities to strengthen protective factors, mitigate risk factors, and build healthy environments within the family, school, peer group, and leisure-time contexts.

**Planet Youth** is an analytics consultancy that offers a 5-year <u>Guidance Program</u> to assist communities with adapting the Icelandic Prevention Model and building permanent capacity to support long-term implementation. Through participation in the Guidance Program, communities receive the core questionnaire, data analysis and reporting of survey results within 8 weeks, intervention recommendations, training, action planning workshops, and other supports and resources. Participating communities become Planet Youth Partners and are responsible for facilitating collective decision-making and collaboration in the community, resource allocation, and the implementation of prevention activities that address the risk and protective factors.

**The Planet Youth Core Questionnaire** is used to collect information from adolescents that is critical for the adoption and implementation of the IPM.

**The Steering Committee** will serve as a project support team for the district and will be responsible for providing advice and support relating to project direction, identifying existing and new funding sources, reviewing the Planet Youth Core Questionnaire, and data report dissemination.

**WHEREAS** at its meeting held on November 21st, 2006, the Council for the Corporation of the Municipality of West Nipissing adopted Policy No. 2006/418, further amended on December 19, 2006 and on November 15, 2011 (copy attached as Appendix "A"), regarding the winter maintenance of privately-owned roads and roads owned by the Municipality but which are yet unassumed;

# NOW THEREFORE THIS AGREEMENT WITNESSETH that the Parties hereto agree as follows:

- 1. The following terms and conditions apply to this agreement:
  - a) "Winter Maintenance" shall mean snow plowing only.
  - b) This Agreement is for Services rendered only.
  - c) <u>ALFRED ROAD</u> must have the appropriate number of permanent residences, being (number to be determined by the Director of Public Works or his / her designate for each road).

- d) The work warranted on the road must be achievable without causing damage to municipal equipment, private property, or risks to public or operator safety in the sole opinion of the Municipality and the Director of Operations.
- e) The Municipality is not responsible for, nor will it upgrade, repair or maintain the condition of the road in any way, means or form at any time during the year.
- f) The Property Owners or the Residents of the Road or the Developer requesting the service shall, at their own expense, visibly erect and maintain in good condition proper and approved signage indicating to all passersby or the general public that the road is not municipally maintained and is to be used at their own risk.
- g) This Service Agreement shall in no way be construed as an acceptance or assumption of <u>ALFRED ROAD</u> or \_\_\_\_\_ subdivision by the Municipality of West Nipissing.
- h) The Landowners or the Developer agree to indemnify and save harmless the Municipality of West Nipissing for any injury, loss or damage of any kind caused as a result of the work being done under this Service Agreement.
- i) The Municipality of West Nipissing shall not be responsible for any deterioration of the road or any private property during the term of the Service Agreement, whether such deterioration results from its own activities related to snow plowing or from any other activity or natural process.
- j) The Municipality of West Nipissing reserves the right to withhold the services due to poor or unsafe conditions at any time during this agreement. Poor or unsafe conditions will be deemed so at the sole \discretion of the Municipality as determined by the opinion of the Director of Operations or his or her designate.
- k) The Municipality reserves the right to withhold the services if it is deemed, in the sole opinion of the Municipality, that providing the services would damage the road and / or snow removal equipment.
- I) Roads under this agreement shall all be considered as Class 6 under the Minimum Maintenance Standards for the Province of Ontario, which means that there is no standard included in Ontario Regulation 239/02 as to the amount of snow accumulation required before deployment and the time lapse after a snow event before any snow plowing of the road will occur.
- 2. The Term of this agreement shall be from the date that all signatures have been obtained until March 31, of the following year.
- 3. There shall be no cost related to this snow plowing agreement.
- 4. Entering into this agreement shall not imply that an agreement will be renewed. The road shall be reviewed on an annual basis. Any repairs or upgrading required to bring the road to an acceptable state for service under this agreement shall be done by the property owners, who will bear all costs associated with the repairs or upgrading. Once the repairs

or the upgrading has been completed, the Director of Operations or his or her designate, shall, upon request, re-inspect the roadway to ensure that it is acceptable for winter service and shall notify the property owners' representative of his or her findings.

- 5. The Landowners or the Developer understand and agree that failure to follow any of the above **TERMS AND CONDITIONS** may result in the termination of this agreement. This agreement may also be terminated at any time by either party for any reason.




